Re: Examinees' Right to Bring Menstrual Products into Bar Exam

Dear Bar Admissions Administrators:

We are law professors and lawyers who have taken bar examinations and understand their role in regulating the legal profession. We write to request that the West Virginia Board of Law Examiners (WVBLE) revise its policy regarding examinees' right to bring their own menstrual products to the July 2020 in-person bar exam.

Currently, the WVBLE does not include menstrual products in the list of "[t]he only items allowed in the testing room[.]" The relevant text in the *Frequently Asked Questions (FAQs)* continues, "Nothing else is allowed. The WVBLE will provide exam items as well as, ear plugs, tissues, and first aid and feminine hygiene products." We understand that examinees also received correspondence identifying "feminine hygiene products" as among those items "prohibited in the testing room," unless pre-approved. Although it is helpful that the WVBLE is providing menstrual products during the exam and allowing "pre-approval" of such products, the prohibition against examinees' bringing their own personal products without pre-approval results in test-taking conditions for applicants who menstruate that are more onerous and stressful than for other applicants.

Within the past-twenty-four hours, Edythe Nash Gaiser, Clerk of Court for the Supreme Court of Appeals of West Virginia, clarified the West Virginia policy to Kathryn Rubino at ABOVE THE LAW, who reported:

folks taking the bar exam will be able (and have always been able) to access their own feminine hygiene products during the course of the exam. Though they are not allowed in the testing room, personal products including menstruation supplies can be left just outside of the testing area. Gaiser says that proctors can accompany test takers as they get the menstruation products they've brought or that proctors can hold the products for applicants as they take the exam and they're able to access their own menstrual products

whenever they need to. The feminine hygiene products provided by WVBLE are in addition to whatever an applicant may bring (but not take into the actual testing room).<sup>4</sup>

We appreciate that the WVBLE does, in fact, permit examinees to bring their own menstrual products. However, it is very concerning that this permission is not expressly and publicly included on the website's FAQs or elsewhere. Accordingly, examinees may not know that bringing their products is permitted. In addition, this process requires an examinee to: 1. Waste time going to a proctor and then outside the examination room to retrieve one's products; and 2. Disclose to a proctor that one is menstruating and needs products. Bar exams are stressful and time-sensitive. This unpublished policy, which contradicts the information in the FAQs, does not relieve these issues for examinees who menstruate.

We recommend that this illogical and shaming policy be rescinded or revised to permit examinees to bring in their own menstrual products and keep them at their test-taking area. Further, the revised policy should be expressly written and publicly accessible. Menstrual products are essential items and should not be treated as a security-risk.

Without doubt, many people taking the West Virginia bar examination later this month—women, transgender men, and nonbinary persons—will be menstruating. It is critical that they have access to their own menstrual products during the exam. WVBLE's provision of products in the exam room's restroom does not solve this problem. Menstrual products are not "one size fits all." Persons who menstruate require different sizes and levels of absorbency in their products to best fit their body and menstrual flow. For this reason, products come in different sizes and absorbency levels. A tampon that is too large for a particular user may cause pain or discomfort—and, in fact, may be unusable. Even worse, it may make the applicant susceptible to toxic shock. A product that is too small may lead to leakages and a distracting and time-consuming mess for the applicant to deal with in the middle of the exam.

Menstrual pads also come with different levels of absorbency and types of adhesion (such as wings to attach to underwear) that also make them unique and appropriate for handling one's flow. Further, some individuals need to use organic or other non-generic products to prevent allergic reactions from ingredients that are used in some standard products. Without being able to read ingredient lists or test the product in advance, applicants may experience vaginal itching or other problems caused by inserting foreign products inside or adjacent to their bodies. In addition, it is not clear whether the ban on bringing in menstrual products also bars applicants from removing, cleaning, and reinserting a menstrual cup during the exam.

Another concern with the WVBLE policy is that it is unclear if menstrual products will be provided in all bathrooms. Transgender men and gender nonbinary persons menstruate.<sup>6</sup> They

may use the male restrooms or all-gender restrooms (if available). If menstrual products are available only in women's restrooms, and these examinees are not permitted to bring their own products or do not know that they are permitted to do so with advance permission, they will be wholly without access to these necessities during the bar exam.<sup>7</sup>

We assume that the WVBLE is concerned about test security. Precluding examinees from bringing in their own menstrual products, however, appears to be based on an ill-founded concern that they might write information needed for the exam on these products. It seems impossible that one could write anything meaningful on a product or its wrapping for a two-day intensive test that requires not only rule recall, but also application and analysis of legal rules to facts. The policy also seems to unnecessarily raise suspicion only about persons who menstruate. For example, the policy permits applicants to bring in other items that are deemed essential—such as laptops. Access to one's own menstrual products are just as essential. And such access should not require the examinee to take extra time away from their exam. Absent any indication that menstrual products have been used to compromise the integrity of the bar examination, bar examiners targeting only people who menstruate sends a strong—and problematic—message that people who menstruate are untrustworthy.

For these reasons, we ask the WVBLE to amend its policies to expressly and publicly allow examinees to have unencumbered access to personal menstrual products during the upcoming July bar examination. Attached is a letter signed by over 2800 law professors, law students, lawyers and other members of the legal community sent to the National Conference of Bar Examiners requesting support for the same clear policy for all state bar examinations. Multiple signatories are from the West Virginia legal community.

Re: Examinees' Right to Bring Menstrual Products into Bar Exams

## Dear President Gundersen:

We are law professors, lawyers, recent law school graduates, and law students who have taken or will take bar examinations and understand their role in regulating the legal profession. We write to request that the National Conference of Bar Examiners (NCBE) establish a policy that prohibits state bar examiners from preventing bar examinees from bringing personal menstrual products into the bar exam. While the NCBE does not prohibit test takers from carrying menstrual products into the Multistate Bar Examination (MBE), some states currently do explicitly ban them. This is an illogical, shaming policy that has the potential to significantly harm those test takers who may be menstruating when taking the bar exam.

The proposed solution offered by some states is to provide menstrual products in women's restrooms. Although it is helpful to provide such products, the prohibition against applicants' bringing their *own* products as well as the provision of products only in women's restrooms—and not all restrooms, results in test-taking conditions for examinees who menstruate that are more onerous and stressful than for other people. Accordingly, we ask the NCBE to insist that state bar examiners remove any such prohibitions from their policies.

Without doubt, many people taking bar exams in the coming months—women, transgender men, and nonbinary persons—will be menstruating. It is critical that they have access to their own menstrual products during the exam as opposed to only unknown and likely uniform products that are provided by a state board in a restroom. Menstrual products are not "one size fits all." Persons who menstruate require different sizes and levels of absorbency in their products to best fit their body and menstrual flow. For this reason, products come in different sizes and absorbency levels. A tampon that is too large for a particular user may cause pain or discomfort—and, in fact, may be unusable. Even worse, it may make the applicant susceptible to toxic shock.<sup>2</sup> A product that is too small may lead to leakages and a distracting and time-consuming mess for the applicant to deal with in the middle of the exam.

Menstrual pads also come with different levels of absorbency and types of adhesion (such as wings to attach to underwear) that also make them unique and appropriate for handling one's flow. Further, some individuals need to use organic or other non-generic products to prevent allergic reactions from ingredients that are used in some standard products. Without being able to read ingredient lists or test

the product in advance, applicants may experience vaginal itching or other problems caused by inserting foreign products inside or adjacent to their bodies. In addition, it is not clear whether the ban on bringing in menstrual products also bars applicants from removing, cleaning, and reinserting a menstrual cup during the exam.

Another concern arises if the state boards provide menstrual products solely in women's restrooms. For instance, transgender men and gender nonbinary persons menstruate.<sup>3</sup> They may use the male restrooms or all-gender restrooms (if available). If menstrual products are available only in women's restrooms, and these examinees are not permitted to bring their own products, they will be wholly without access to these necessities during the bar exam.<sup>4</sup>

We assume that bar examiners are concerned about test security. Precluding examinees from bringing in their own menstrual products, however, appears to be based on an ill-founded concern that they might write information needed for the exam on these products. It seems impossible that one could write anything meaningful on a product or its wrapping for a two-day intensive test that requires not only rule recall, but also application and analysis of legal rules to facts. The policy also seems to unnecessarily raise suspicion only about persons who menstruate. For example, the policy permits applicants to bring in other items that are deemed essential—such as laptops. Access to one's own menstrual products are just as essential. Absent any indication that menstrual products have been used to compromise the integrity of the bar examination, bar examiners targeting only people who menstruate sends a strong—and problematic—message that people who menstruate are untrustworthy.

That some states also may be offering the bar exam remotely in the Fall does not provide a remedy to this policy issue. While it is true that applicants taking the bar exam at home would have ample access to their personalized menstrual products, the remote exam may offer admission only to the bar where each person is sitting for the exam and thus would not provide portability of the Uniform Bar Examination test result to other jurisdictions. Therefore, the importance of unencumbered access to personal menstrual products during the in-person exam is critical for persons who menstruate.

For these reasons, we ask the NCBE to clarify that examinees throughout the country must be allowed to bring their menstrual products into the bar examination and welcome the opportunity to discuss this matter further.
